SCHEDULE

- Warm-Up from 9:00-9:55am; 10:00am Start

FACILITY

- Mark Twain JHS Pool Complex, 160 Woodlawn Avenue, Yonkers, NY 10704.
- Seven yard lanes for competition; one lane for continuous warm-up and cool down throughout the meet. **NO DIVING** is permitted during warm-up except in designated one-way sprint lane(s).
- Colorado Timing System; Hy-Tek Meet Manager software.

ELIGIBILITY

- Open to all USMS-registered swimmers age 19 and older (as of November 6, 2004).
- **A copy of your current 2004 or 2005 USMS registration card must be included with your entry.**

FEES / ENTRIES

- \$10.00 meet surcharge; \$3.00 per individual event; \$6.00 per relay; payable via check or money order to **CITY OF YONKERS**.
- Maximum of five (5) events per swimmer **INCLUDING** relays.

SEEDING

- All 50-100-200 yard events will be pre-seeded. Enter **YARD** times for all events.
- Events will be seeded slowest to fastest, men and women swimming together in combined heats.
- No Time ("NT") entries will be seeded in the slowest (first) heat.

ENTRY DEADLINE

- Entries must be **RECEIVED** (not postmarked) by Friday, October 29, 2004.
- Relays may be deck-entered until 9:30am. Positive check-in required for Mixed 500 yard Free by 11:00am.

AWARDS / RESULTS

- Ribbons awarded for 1st through 3rd place in all individual events. 1st thru 3rd place trophies for relay events.

DIRECTIONS

- **From the South:** NYS Thruway North to Mclean Avenue Exit (service road exit right after 233rd street exit). Right onto Mclean Avenue for ½ mile. Left onto Woodlawn Avenue. Facility located at 160 Woodlawn Avenue (corner of Woodlawn and Wakefield).
- **From the North:** Bronx River Parkway South to Bronx River Road/Yonkers Exit. Go straight up Wakefield Avenue hill (in between the two gas stations). Facility located at 160 Woodlawn Avenue (corner of Woodlawn and Wakefield).
- **From the Saw Mill River Parkway (North & South):** Take to Cross County Parkway East (stay in right-hand lane) to Kimball Avenue Exit. Make a right and continue south until Woodlawn Avenue (1st left after Yonkers Avenue). Facility located at 160 Woodlawn Avenue (corner of Woodlawn and Wakefield).
- **From the Hutchinson River Parkway (North & South):** Take Cross County Parkway West to Bronx River Parkway South. Get off at the Bronx River Road/Yonkers Exit. Go straight up Wakefield Avenue hill (in between the two gas stations). Facility located at 160 Woodlawn Avenue (corner of Woodlawn and Wakefield).
